SECTION 4: FIRST AID MEASURES

Description of First Aid Measures

SECTION 5: FIRE-FIGHTING MEASURES

Extinguishing Media

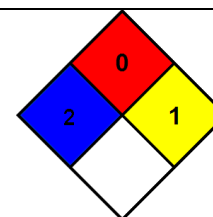
